# Huntingdon Missionary Baptist Church History

Through the inspiration of the Holy Spirit and in honor of our Lord and Savior, Jesus Christ, a group of born again Christians banded together and organized Independent Missionary Baptist Church on May 14, 1950. The organizational sermon was preached by Bro. Hersey Hopper and Bro. Elihu Martin prayed the organizational prayer. Sixteen individuals brought letters of recommendation from sister Baptist Churches and presented themselves for membership to form the new church. Those members elected Robert Noles as Pastor of the church pending his ordination.

The name Independent was chosen because we believe that each individual church is autonomous--selfgoverning--independent of any other organization.

On February 11, 2001, by action of the Church in regular business session, the name "Independent" was changed to "Huntingdon".

### Friday October 9, 2015

On a sunshiny day, we met at Huntingdon Church for our 167<sup>th</sup> Annual Session of the Southwestern District Missionary Baptist Association.

Bro. Ray Smith, moderator, welcomed everyone and asked for all to be in prayer for this session the next two days. He welcomed those from other churches and welcomed the messengers present and hoped we could come together in prayer and worship. He asked Bro. Johnny Carver, McFerrin Church (Wiseman Association), to lead us in prayer.

The moderator then asked Bro. Donnie Hines, McFerrin Church (Wiseman Association), to lead the congregation in singing and asked Bro. Lee Carter, Huntingdon Church, to play the piano. The congregation stood and sang, "I'm Bound for The Kingdom," and "Take My Hand, Precious Lord."

After a few remarks, he read from I John 3:1-3

The Moderator made the following appointments:

#### Committee on Divine Service and Hospitality:

The Host Committee of Huntingdon Church. He introduced the pastor of Huntingdon Church, Bro. Lynn Stapleton. Bro. Stapleton gave a heart-felt welcome and told how thankful he was to be here today. He introduced the deacon body: Bros. Ray Smith, Kenny Rush, Harold Webb, Tommy Moody, and Tommy Crews.

The moderator then asked for the clerk to read the *Rules of Decorum*.

Call was made for the reception of Church letters. Call was made for any petitioning church letters, with none coming forth. Roll call of messengers was made. **Motion and second** was made to seat 44 messengers; **motion carried**.

The association then moved in to the election process.

Bro. Ray Smith, Huntingdon Church, was nominated as Moderator. **Motion and second** was made that nominations cease and elect by acclamation; **motion carried.** 

Bro. Ray Smith assumed the role as the permanent moderator.

Bro. Andrew Stokes, Bible Grove Church, was nominated as Assistant Moderator, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried**.

Bro. Scott Carter, Shiloh Church, was nominated as Clerk, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried**.

Bro. Clint Sanders, Pleasant Ridge Church, was nominated as Assistant Clerk, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried.** 

Five Churches requested the Association to meet with them for the 2016 session. A **motion and second** was made to select Pleasant Ridge Missionary Baptist Church in Benton County as the host site; **motion carried.** 

Bro. Arzell Douglas was nominated to preach the Introductory Sermon, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried.** 

Bro. Chris Wallace was nominated to be the alternate for the Introductory Sermon, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried**.

Bro. Scott Carter was nominated to preach the Doctrinal Sermon and being the only one nominated a **motion and second** was made to elect by acclamation; **motion carried**.

Bro. Jeff Simmons was nominated to be the alternate for the Doctrinal Sermon, and being the only one nominated, a **motion and second** was made to elect by acclamation; **motion carried.** 

With the 11:00 hour near, the moderator asked for a song to be sung while Bro. Trey Crews came to give the introductory sermon. The congregation stood and sang "Won't It Be Wonderful There."

The moderator introduced Bro. Trey Crews as the one selected last year to preach the Introductory Sermon. He told

of knowing Bro. Trey since the day he was born. He told of how Bro. Trey had several generations to attend Huntingdon Church. Bro. Smith told how it reminded him of II Timothy 1:5 and of what a good Christian family Bro. Trey came from. He asked everyone to be in prayer for Bro. Trey as he came to deliver a message from God.

#### Introductory Sermon

Bro. Trey Crews

Bro. Trey Crews shared how special it was to be here today. After a few opening remarks, he told the title of his sermon was "Zombie Apocalypse." Everyone knows what a zombie is. Earlier when we were voting, it seems like we were a bunch of zombies. His goal this morning was to be uplifting, and more honey than vinegar. We need to be honest with ourselves.



He began with the thought on the body. Bro. Trey read in Matthew 16:18 and told how we are the body of Christ as the church. The scripture states "upon this rock I will build my church; and the gates of hell shall not prevail against it." We know she will struggle, but she will always stand. This does not mean we will not face some causalities, but we will prevail.

He read from Hebrews 2:12 and told how the church had been established and how he was in the midst of them, not a universal body, but a visible body. A doctrine exists about a universal church, and Bro. Trey does not believe in that teaching. The body of Christ is one that is visible and seen today. If the church was an invisible body, then how could they administer the two ordinances?

Bro. Trey read Matthew 18:15 -18 and asked how could someone go to the church if it was invisible. He felt that the churches here today are true churches and have authority. The church is ecclesia, a called out assembly that is local and visible.

He referenced the minutes from last year, and noted how we had 54 additions and 66 losses with a total membership of 2,069. By having 33 baptisms and 66 losses, our churches lost double of what joined our churches. Looking at this data, our churches would become extinct in a little over 60 years. He read those numbers to help us see the urgency of the times we live. Before we get in a zombie state, we need to check ourselves. Is there a pulse there (and be honest)? Are we in a zombie state-walking dead? He referenced the book <u>The Au-</u><u>topsy of the Dying Church</u>. He told how it talks about a healthy church, symptoms of sickness in the churches, very sick churches, and dying (eternally ill) churches. With God all things are possible, but the problem with the dying churches is the fact they were in denial about the fact they were dying. Before the body gets to the zombie state, we must have checkups. We need to check the pulse of each of our churches and see if there is a pulse. Our churches do not need to be naïve or hypocritical and just going through the motions of church.

He read from Revelations 3 and talked about three churches of Asia (visible, local bodies). He talked about the church at Sardis and how they were dead. As we check our pulses, his prayer was that we would all find ourselves being like the church of Philadelphia. The church of Smyrna was a church that was suffering. When the church was persecuted and became uncomfortable and out of their comfort zone, then they were on fire and the gospel was spread. The last church, Laodicea church, is the phase of the church we are in today. This was a church that was lukewarm, neither cold nor hot. The scripture states, "I will spue thee out of my mouth." Thinking about the Laodicean church, does this scare you in the day we live in? They were located in a valley with easy travel. In that city was a manufacturer of black wool for clothing, and close by was a school of medicine that was known for eye salve used to heal eye sight. They had lots of traffic, and a wealthy city. Considering these facts about the Laodicean Church and the necessities we have available today, are we lukewarm? We must be born again-be alive and not dead.

Bro. Trey then stated that after you have checked the pulse, you must make a diagnosis and treatment. He read from Proverbs 29:18 and spoke of where there is no vision, the people perish. The church needs to have a vision. What is our vision? What is our purpose? The dying church would be a church that was living in "the good old days." Are we living in what is behind, or what is ahead? We must look forward and not back-finish strong. Our strength is in Jesus and he is our antidote.

He had on his heart that we need to be willing to hold on to sound doctrine, but be willing to change traditions. As his children, we need to discern the will of God. We often tell ourselves, "This is what I want" instead of saying, "what does God want." Sometimes it feels better to hold on to the things and the devil uses this against us. The true gospel message does not change. The way or how we deliver it, may change. As preachers and pastors, we need to realize the world we live in is getting smarter and smarter. We cannot always stand and deliver the milk of the work, but also the meat to satisfy our members. We must compel them to come in to hear the gospel.

The vision or mission we need to have comes from Matthew 28:19, the Great Commission, and how we are told to go. We must be willing to move and be active. We cannot sit still and be comfortable, we must go. Sometimes, we as Christians do not have a vision. Whose fault is that? We must go, teach all nations, baptize them, and observe all things. This great commission makes us get out of our comfort zone and trust in him; he will be with you alway.

Missionary Baptist churches, are you listening? We need to understand that we hold the truth, and we should not be afraid to go out and share it to this world. The Creator is on our side so go ye therefore and sell our product. We must be urgent because Jesus is coming soon. Check your pulse. Are we passionate about the cause? Are we experiencing gradual change, and it is catching us not prepared? Be the church in Philadelphia. Bro. Trey referenced the recent movie "War Room." Our lives should be as in the movie where we enter our "War Room" - closet to be earnest in prayer. We should pray about meaningful things and talk to God.

In John 6:60-69, Jesus was talking about tough topics. The multitude that had been following Jesus only followed him until it got hard. Are you a zombie or walking dead and not really active for the cause of Christ? Are people offended at being called "zombies?" When it gets hard, do our church members just want to move on? Any members today want to go to other churches where the "grass is greener?" Jesus asked the twelve if they too would go away (John 6:67). Don't be like Peter and deny Christ. Stand strong and be like Peter in John 6:68 "Lord, to whom shall we go?" We must check our pulse and have a strong heart. Truth (antidote) is in front of us, and it is Jesus. We must wake up and realize the urgency; he could come any day. Be willing to share our beliefs outwardly in the community and to all nations but do not forget local mission field. We must examine ourselves. It is good to be a child of God.

Scripture tells us to suffer persecution for His name sake not tradition sake. Our tasks may seem large, but may we always know that God is bigger.

After a few closing remarks, Bro. Trey turned the service back over to the moderator.

The moderator called for a song so we could give the right hand of Christian fellowship to Bro. Trey.

**Motion and second** was made to dismiss one hour for lunch; **motion carried.** The moderator asked Bro. Billy Moran, Fairview Memorial Church (Siloam Association), to dismiss the morning session and to ask the blessing on the food.

Friday Afternoon

Bro. Smith welcomed everyone back from lunch and asked Bro. Johnny Sanders, Bible Grove Church, to lead us with a song with Bro. Lee Carter, Huntingdon Church, playing the piano. The congregation began the afternoon session by singing "Jesus Hold My Hand." The moderator called on Bro. Ronnie Stewart, Rushing Creek Church, to lead us in prayer.

The moderator opened the afternoon session by reading Colossians 3:12-17.

The moderator asked for a song to take up the annual offering for the Associational Missionary. We stood and sang "Victory In Jesus."

The moderator called for the **Associational Missionary Report** 

Bro. Dennis Lunsford told how thankful he was for the messengers putting their confidence in him this past year. He told how he was privileged to visit each association church this past year on more than one occasion. He also told how he was able to visit the Wiseman Association and Siloam Association.

As Associational Missionary, he traveled approximately 4,000 miles and received offerings of approximately \$1,100. He expressed that he did not have any intentions to receive any money for his labors.

**Motion and second** was made to elect Bro. Dennis Lunsford as the Associational Missionary for another year; **motion carried**.

The moderator gave Bro. Rick Jones an opportunity to speak since he would not be present on Saturday to give a missions report. Since being authorized to begin the work in Jamaica, he told how many present had supported the work in Jamaica. He told how this past summer Craighead Church ordained their first Jamaican pastor. Bro. Jones also told about a young man that had been after him to come to Nassau Bahamas and do a work there. Bro. Jones told how the Lord opened the door this past August. He told about the doors that were opened, and for the desire he has to return to the island soon.

The Clerk read correspondence from the Siloam Association, Wiseman Association, and Big Bear Creek Association. **Motion and second** was made to include these in our minutes; **motion carried**.

**Motion and second** was made to give the chairman 10 minutes for discussion and the assistant 5 minutes; **motion carried.** 

The moderator called for the report on **Characteristics of Effective Church Membership.** 

According to our doctrine and faith, the only thing that is required for you to become a church member is to be a baptized believer. Upon giving your personal testimony of salvation, you are baptized by the authority of the local church body to which you are joining. There is much to be said about and a great deal to gain from discussing personal salvation and proper baptism. However, this report is about the characteristics of "effective" church membership. All our churches have a frustratingly large number of people with their names on our books that we would have a difficult time admitting were "effective" members. With that thought, there are also many things that can be discussed on how 'not' to be an effective church member. For the sake of brevity and clarity, we will focus on seven traits of an effective church member and what the Bible tells us in that regard.

The first and most obvious characteristic of an effective church member would be regular attendance. In my opinion,

this would be the minimum effort of an effective church member. However, you could also consider it the foundation to which the other traits can rest more firmly. Regular attendance puts the church member right where they need to be in order to be most effective. No company has ever increased its profits by having all its employees stay home from work. No school has ever increased test scores by increasing the absences of the students and teachers. Being in regular attendance makes you a reliable and beneficial part of the church. Where two or three are gathered. He will be in the midst. But, how much more can He accomplish if everybody showed up. There is a areat comfort in being reliable. The church needs people there and the most effective church members are on the pew Sunday after Sunday, service after service. The greatest compliment l've ever heard towards a church member was, "She's there every time the doors are open." The benefits to your soul and your relationship with God are innumerable. The benefit to the church of a regularly attending member is truly the foundation of effective church membership. (Hebrews 10:25; Matthew 18:20)

The second trait of an effective church member is to actively serve the church. We all have something to contribute. We don't all preach and teach, but we can all say 'amen' and study the Sunday school lesson to be ready to contribute to the class. Saying 'amen' to a Baptist preacher in the pulpit is like siccing a coon dog. Pastors preach harder when they see the congregation is listening and engaged. Teachers are encouraged when they hear feedback and discussion on the topic. Song leaders do a much better job when everyone in the house is lifting their voice to God. There are many other tasks that can be accomplished from a willing church member. Just a handful of good examples are: cleaning the church, taking care of the regular maintenance of the building, sending out sympathy cards, bringing food to church meals, keeping an eye out for people that miss and checking on them, managing the sound system, keeping the parking lot clean, or even just greeting people at the door. An effective church member is willing to do whatever they have the ability to do to serve the church, whether it's a big job or a small one. One of the most powerful things an effective church member can do to bless the church body is help with visitation. Every church has only one pastor. He can't be everywhere and pastors have families, too.

Deacons can help with this, but every member represents the church. An effective church member can run out to the hospital, stop by the home of a widow or pick up the phone just as easily as the next person. How many times has someone complained that their church wasn't doing something when that very person had the ability to do exactly what they wanted to see done? (*1 Corinthians 12:12-29; James 1:25-27*)

The third trait of an effective church member is to help the church grow. There were three thousand souls saved on the day of Pentecost. The Holy Spirit did not look at that as a finish line goal and let the new members just sit back and relax. By the leadership of God, those new members immediately spread the Gospel to their friends, relatives and neighbors. As the Spirit moved, others were touched by the Word of God and "...the Lord added to the church daily such as should be saved." (Acts 2:47) An effective church member still seeks to add to the church. They will invite their friends and family to attend and tell them exactly why they would benefit from being there. Sometimes it takes a great deal of courage just to ask someone to come to church. But, the best way to get someone to actually make the effort to come is to give them a great reason to do so. People are more inclined to visit a church that has happy members that can't stop talking about how great it is to be there every Sunday. It's okay to talk about your pastor behind his back, if you're telling your neighbor how great he is. Spread all the gossip you want about how your Sunday school class is the happiest time you experience your whole week. You can be forgiven for bragging about how your church has the best congregational singing that you've ever heard. Pastors come and go. If a person visits a church because of the preacher, what will they do when the Lord carries that man away? Permanent growth in a church comes from effective church members bringing people in and establishing a relationship with them that is lasting. (*Matthew 28:18-20*)

The fourth trait of an effective church member is to represent the church well in the community. Done well, this can be a great benefit to the previous trait of growing the church. We have all heard many times that every member represents the church. The most effective church members live their lives in such a way that it gives the church a wonderful reputation by association. We can discuss at length the teachings of Christ that should govern our behavior and attitude. An effective church member will seek to live for the Lord, abstain from sinful behavior and let their light so shine before their neighbors that they might be a beacon pointing the sinner to their church. Sadly, one of the main excuses people use to not attend church is the character of the ones that do attend. An effective church member will not be someone's excuse to avoid church. An effective church member will lead a life that causes others to say, "I'd love to sit on a pew with that guy." (*1 Corinthians 5:9-13*)

This next trait may be the least popular to mention. The fifth trait of an effective church member is to contribute to the finances of the church. This is a separate topic on the schedule this year, so there's no need to discuss it in detail. However, it must be noted that an effective church member recognizes the financial need of their church and contributes as much as they possibly can. Tithes and offerings are taught throughout the Old & New Testament. It is obvious that a church must have money to accomplish its work. Not only does the light bill have to be paid, churches have to be ready to fly to the relief of its members and neighbors in need. The only way the church can be equipped financially is with the contributions of its members. In the days after Pentecost when the church was growing rapidly and the Spirit of God was moving unimpeded in the hearts of God's people, they saw clearly that their worldly possessions served the whole of the body of Christ greater than keeping them to themselves. Ananias & Sapphira were church members, too. Their greed destroyed them and they couldn't take their money with them. (Luke 11:42; Acts 4:31-5:11)

The sixth trait of an effective church member is to actively participate in the church business meetings. It would seem that this trait would be covered by the first mentioned trait of regular attendance. Unfortunately, some members will faithfully attend every church service except the business meeting. For churches that have their business meeting after morning worship, there are a significant number of members that will get up and leave, but would be happy to stay if there was a meal. If the business meeting is at a separate time, it can be almost impossible to get some to return for it. One of the unique qualities of a Baptist church is that we have a congregational form of government. Every member can vote and every vote matters. The government of our nation was based in part upon the concept of Baptist church government. If there's only a small number of

members that are willing to attend the business meeting, the church is ruled by a committee by default. The most effective members are at the business meeting, staying informed, contributing their helpful opinions, and helping the church to decide matters based on collective wisdom and thoughtful consideration. All too often, business meetings become the most stressful time we spend in church. They don't have to be. An effective member not only interjects their own opinion, but they respect the opinion of their fellow members. Everyone votes their heart and conscience, but if you lose the vote you still support the church and the work trying to be accomplished. The most effective church members can vote differently and still love and respect each other after the votes are counted and the meeting adjourned. How can we ever expect Congress to get along if we can't even cooperate in the Lord's house? (1 Corinthians 6:11: Matthew 18:15-22)

The seventh & last trait to discuss may very well be the most important. An effective church member will contribute spiritually to the church. There are many different ways this can be accomplished. An effective church member will be familiar with the doctrine and faith of the church to which they belong. They will hold this faith securely in their heart and be ready to defend it with scripture and truth. An effective church member will not be satisfied with the milk or basic principles of their doctrine. They will seek to grow in God's word and be ready for the strong meat that will nourish them spiritually. Another spiritual contribution that can be made is to be a peaceful and prayerful member full of praise for God. "The effectual fervent prayer of a righteous man availeth much."(James 5:16) The member who comes to church praying adds great blessings to the service. An effective church member prays not only for the pastor and church officers, but prays for every member, for the sick & hurting, for the lost and for the glory of God. (Hebrews 10:23-25; Hebrews 5:12-14; 1 Peter 2:1-17; 1 Corinthians 11:17-34)

All of us can think of someone in our church that fits some or all of these traits. The most notable part of this report, though, is that every one of us is capable of every trait discussed. How much better would our churches be with more effective church members? How far might the Gospel spread if our churches only had more effective members? How much better could our communities be if more believers sought to not just be a member, but to be an effective member of Christ's church?

The moderator then called for the report on **Financing the Lord's Work**.

#### Financing the Lord's Work

2015 Southwestern District Association of Missionary Baptist Churches

We, your committee on Financing the Lord's Work are grateful to be attending this, the one hundred sixty seventh session of the Southwestern District Association of Missionary Baptist Churches. Through the years, Financing the Lord's Work has been a topic often repeated. In the beginning years of this association, this subject was repeated from year to year without interruption. And while we may have made modest gains in our understanding of the subject, doubtless it is of great concern to us because of its frequent appearance.

The Barna Research group has been conducting research surveys of Christian trends and activities since 1984. In their recent survey on tithing conducted in 2007 the following statistics were gathered:

84% of all adults (religious or not) contributed to a church or non-profit organization.

Of that 84%, Christians were overwhelmingly the most generous.

Among all born again Christians, only 9% practiced tithing.

Among Evangelicals, 24% were giving tithes.

12% of Conservatives and 11% of Charismatics reported tithing.

It is well known among us, that tithing is a hotly debated biblical doctrine. While some argue that it is only applicable to the Old Testament economy of Judaism, others insist that it is to be practiced by the New Testament Churches of Jesus Christ. This age old debate will likely never be settled, but it is apparent that the recommended "free-will giving" or "giving as one purposes in his heart" is leaving churches and ministers in want of necessary financial resources.

The record of Israel's giving to build the Tabernacle is thrilling. Especially when Moses and Aaron asked them to stop giving because they had more than enough to complete the most magnificent tent ever imagined. Equally thrilling, is the record of King David's provisions for a temple his son, Solomon would later build. In today's money, David set aside billions of dollars in gold and silver to build the most expensive building for its size ever built. In contrast, it is disturbing that the Old Testament ends with an indictment upon Israel for robbing God. Their captivity in Babylon was because of idolatry, but the seventy year duration was exactly in proportion to their robbing God for four hundred and ninety years of His Sabbath rest.

God in the beginning gave man dominion, oversight over the earth and all that is in it. None would argue that we are to be good stewards of what God has entrusted to us. Jesus tell us to whom much is given much shall be required. The church Jesus built has been entrusted to us in the very same way and to be good stewards we are responsible to preach the word and reach the world. That cannot be accomplished without the generous giving of men and women who have an overflowing gratitude for all that God has done for them.

As Missionary Baptists, we are forced to rely on public schools to educate our young children, and colleges and universities that are increasingly more humanistic, ungodly and wicked for their further education. We have consigned our children's education to the secular world and subjected them to the influence of the world and wonder why we are losing our youth.

In these two thousand years since Jesus commanded the church to go into all the world and preach the gospel we have not recognized that ministry should be our first and full time priority. Missionary Baptists are between a rock and a hard place because Ministers are reluctant to preach tithing for fear that it appears self serving, and church members fail to practice tithing because they have not been properly taught their responsibility to do it.

While the debate over what is the Scriptural way to fi-

nance the Lord's work continues without agreement, human reason fails to find a more logical and fair way to support the church and the ministry other than tithing. Under this biblical system the rich and poor are on level ground. It is no more difficult for the one who has little to tithe on so little as it is for the one who has so much to tithe on so great a sum. And for those who by faith trust in the Lord to practice tithing, both rich and poor stand as equals in doing their fair share.

Proverbs 3:9 & 10 says, "Honor the Lord with thy substance, and with all thine increase: So shall thy barns be filled with plenty, and thy presses shall burst out with new wine." Malachi 3:10 says, "Bring ye all the tithes into the storehouse, that there may be meat in mine house, and prove me now herewith, saith the Lord of hosts, if I will not open you the windows of heaven, and pour you out a blessing, that there shall not be room enough to receive it." These are Old Testament Scriptures, but their significance and their promises are still valid today.

In the New Testament we read the words of Jesus in Matthew 6:17-19, "Lay not up for yourselves treasures on earth, where moth and rust doth corrupt, and where thieves break through and steal: But lay up for yourselves treasures in heaven, where neither moth nor rust doth corrupt, and where thieves do not break through and steal: For where your treasure is, there will your heart be also" In Luke 6:38 Jesus said, "Give and it shall be given unto you; good measure, pressed down, and shaken together, and running over, shall men give into your bosom. For with the same measure ye mete withal shall it be measured to you again." The Apostle, John said in 1 John 2:15 "Love not the world, neither the things that are in the world. If any man love the world, the love of the Father is not in him."

In 2 Thess 3:8 the Apostle Paul prided himself for making his own way in the ministry and not being chargeable to any man. But this same faithful servant of God, referring to the ministry said in 1 Cor 9:14, "Even so hath the Lord ordained that they which preach the gospel should live of the gospel." Every believer is responsible to support the ministry and we can only imagine what more the ministry and the church could do if more then 24% of the Lord's people believed in and practiced tithing.

The topic Financing the Lords Work was read, adopted,

and spoken to by Brothers Lynn Stapleton, Clint Sanders, Ray Smith, Andrew Stokes, and Ronnie Stewart.

With no other business, **motion and second** was made to adjourn until 10:00 a.m. Saturday; **motion carried.** 

The moderator then asked for any announcements before asking Bro. Bob Vanderpool, Mt. Lebanon Church (Siloam Association), to dismiss us in prayer.

In accordance of the Rules of Decorum, we opened the session in prayer led by Bro. Randy Thompson, Cross Roads Church.

The congregation began with singing "In The Sweet Forever" and "I'll Live On" led by Bro. Harold Eubanks, Huntingdon Church, with Bro. Lee Carter, Huntingdon Church, playing the piano.

Bro. Smith read from I Thessalonians 5:12-24. The moderator took a moment to acknowledge the passing of Bro. Marshall Gurley. Bro. Gurley was often present at our meetings and will be missed by the churches throughout the association.

Roll call of messengers were made. **Motion and second** was made to seat the 43 messengers present; **motion carried**.

#### **Report from Historical Committee:**

Not much to report. The committee is focusing on collecting all the minutes back in.

The moderator called for the report on topic *Importance* of the Family and its Contributions to the Local Church The Importance of the Family and Its Contributions to the Local Church

We believe that we see the importance of the family as we look back into the Book of Genesis were God created all things in six days and when He had finished, Gen. 1 : 31 - "And God saw everything that he had made, and, behold, it was very good. And the evening and the morning were the sixth day." He didn't say that it was okay, or that it was pretty good, but that it was very good. There seems to be a sense of joy and satisfaction over all of His creation. There was light to divide the darkness, land and water, the plant world, the sun, moon, and stars for signs and seasons, birds of the air and fish of the sea, and the animals upon the land and God said that all was very good.

But when God looked upon His greatest creation, the creation of man, that was created in the image and likeness of God Himself, He said, "It is not good that man should be alone; I will make him an help meet for him." (Gen. 2:18). It was the absence of the woman or the family that God saw about His creation that was not good, man would be lonely with no one to share his life. And it was the creation of the woman that brings about completeness to both the man and the woman. They complement each other and one is not complete without the other, thus forming the family.

We also want to state that we believe that the only true family that is recognized or sanctioned by God is a union that joins one man and one woman exclusively married to each other as described in the Holy Scriptures.

The Lord's purpose in instituting the family, would not only satisfy the need for human companionship. God had said that it was not good for man to be alone and by creating an help meet that the two husband and wife could spend their lives together. This would not only satisfy the need for companionship, but would also provide a profound environment that godly children could be raised. God told man to be fruitful and multiply at different times (Gen. 1:28: 8:17: 9:7). This commandments reason is so that God fearing children might be raised up. God's command to the children of Israel in Deuteronomy 6:1-9 applies as much to us today as it did to them then. Paul also said in Ephesians 6:4 - "And, ye fathers, provoke not your children to wrath: but bring them up in the nurture and admonition of the Lord. Strong's concordance says nurture means: the whole training and education of children (which relates to the cultivation of mind and morals, and employs for this purpose now commands and admonitions, now reproof and punishment) It also includes the training and care of the body. And the word *admonition* means: exhortation.

Therefore we believe that the Bible teaches us that the family is the best environment for raising children, not only because it provides for the children's protection from harmful influences during their development, but should also provide intense instruction in the way of The Lord. We as parents have an obligation to raise up God fearing children and fathers especially as heads of the household or family will be accountable for failing to do so. And when we raise up God fearing children it will provide a stabilizing unit for all of society, and especially for the Lord's houses of witness (Israel in the Old Testament; and the church in the New Testament).

The family is a foundational institution. And any society is only as strong as the families that make it up and the same is true for the church, it is only as stable, strong, and godly as the families that make up its body. We believe that we can honestly say as the family or home goes, so goes the church, so goes the community, and so goes the nation. This is the main reason there is such an attack by satan to destroy the basic Biblical teaching of the family.

In our Church Covenant, which is an agreement between saved individuals by which they associate themselves into a local church that sets forth their <u>mutual engagements</u> as members of one body. It is here we find in paragraph 1, first an obligation as individuals - that after being saved by grace thru faith, we are to receive scriptural baptism. Thus entering into covenant with other believers of that local church. Then in paragraph 2, there is the promise as Christians - promising to walk together in Christian love - to strive for the advancement of the church in knowledge, holiness and comfort - to promote its prosperity and spirituality - to sustain its worship, ordinances, discipline and doctrines and to contribute cheerfully and regularly.

Then in paragraph 3, the families obligation as church members is found – To maintain family and secret devotions to religiously educate our children and to seek the salvation of kindred and acquaintances. In paragraph 4, is the relationship of church members to each other and in paragraph 5, the responsibility of a member when leaving a church.

Heb. 10:25 - "Not forsaking the assembling of ourselves together, as the manner of some is; but exhorting one another: and so much the more, as ye see the day approaching." It is so important for us to come together for worship, to pray together, to rejoice and to encourage one another, to comfort one another during times of sorrow, sickness and reach out to a lost and dying world with the message of hope. As families and especially Christians we should enjoy and look forward to being together at any and every occasion, especially for church - we need each other. The writer here in Hebrews said, "and so much the more, as ye see the day approaching." The Psalmist also said in Psalm 122:1 - "I was glad when they said unto me, Let us go into the house of the LORD."

The Christian home or family, is the most important part of life, of the church and also the community. As we said earlier the spiritual climate of a church is determined by the homes or families that make it up. And we can safely say as the family goes - so goes the church, so goes the community, so goes the state, and so goes the country.

A Christian family is a place where Jesus is the most important part of their lives.

A Christian family is a place where there is love. I Cor. 13 A Christian family is a place where the Bible is of utmost importance.

Maybe the question ought to be - What can we do to strengthen the family? That in turn our churches might flourish and be a light in the community.

We believe that the importance of the family to the church in regard to the older or elderly members is extremely important. Their contribution to the church of their wisdom and knowledge and experience of life and church life and practices (Titus 2:1-6).

We also find the importance of the family in its financial contributions to the Local church. The church depends on the financial support of its members or families. Tithing to the church is not preached or taught as it once was. Incomes are cyclical over the lifetime of members. The generation that grew up understanding the concept of tithing is now older and not making the income they did in their prime. They still "tithe" but the amount has changed. Many of the younger generation don't practice "tithing." The church cannot and will not survive (financially) if this continues. The local church needs each generation to understand the importance of giving to the church in proportion to the Lord's blessings. And we know that there are many scriptures in the Bible on giving to the Lord.

We can also see the importance of the young people, the young families, to the local church. Our churches need the "energy" of young families to contribute to the church. Many of the programs (VBS, Christmas programs, Fall festivals, etc.) and also maintenance issues about the church need the contributions of our younger members to not only bring their families, but to assist and direct or coordinate these activities.

In closing, we believe that the family is of utmost im-

portance to the local church and we need to raise up Christian families that will in turn strengthen our churches. Men, women, boy and girls indoctrinated in the truth, sound in the faith and ready and willing to stand for The Lord. What we are trying to emphasize is that it takes all ages and stages of families to build a successful church. They are all important and all serve unique and important roles depending on whether they are physical and also scriptural responsibilities. Without godly, God fearing children were will our churches be tomorrow? They are the future.

The moderator called for the topic **Is Sunday School Still Relevant Today?** 

#### Is Sunday School Still Relevant Today?

Is Sunday School still relevant today? To answer this question briefly is not an easy task. Sunday School is important in the spiritual development of Christians because it provides time for learning. Sunday School sets the stage for a better understanding; it is a comprehensive way of learning from one another and an opportunity to receive encouragement to live by God's Word. Sunday School is also important because it provides additional opportunities in the fellowship of learning. Visitors, children, and church members can get to know one another better in the smaller setting and therefore will develop friendships that will produce a greater commitment to the Church.

Deuteronomy 6:7 "And thou shalt teach them diligently unto thy children, and shalt talk of them when thou sittest in thine house, and when thou walkest by the way, and when thou liest down, and when thou risest up."

We see from the commandment of our Lord in the above scripture the need to educate our children in the statutes and ways of our God continually, not just once or twice a week. There has never been a greater need for the increased teaching of the truth of God's Word in our society and especially our churches. How many of us can remember when the Missionary Baptist Church over "there" was a strong vibrant church, only to be now reduced to either a small handful of members in attendance or to have completely left the True Gospel of Jesus Christ? These things did not happen overnight. Generally speaking, it has been a slow decline in the teaching of the true doctrines of scripture. Galatians 6:6 "Let him that is taught in the word communicate unto him that teacheth in all good things." The word communicate, according to Strong's Concordance, comes from the Greek word koinoneo, which literally means to share with others. If we as pastors, preachers, deacons, elders, Sunday School teachers and even lay members do not continue to pass on the truths we were taught by our forefathers who will?

We send our children off to a public school system that teaches things that are contrary to the Bible, (no fault of the teachers, fault lies with our federal government). Now we believe a good education is of great importance. However do we stress a good education for the proper reasons? A Literacy Law passed in 1690 in Connecticut stated:

"This [legislature] observing that... there are many persons unable to read the English tongue and thereby incapable to read the holy Word of God or the good laws of this colony... it is ordered that all parents and masters shall cause their respective children and servants, as they are capable, to be

#### taught to read distinctly the English tongue."

This law and others like it had as one of its goals the ability for its citizens to be able to read The Bible. Religious education was the focus of many of the early colleges and universities. Even the esteemed Harvard University was originally started with the purpose of training clergy.

In the Lifeway training guide, <u>Missionary Sunday</u> <u>School,</u> David Francis referred to an 1888 speech by Henry Clay Trumbull. In an address at Yale University Divinity School, Trumbull argued that "family education" was indeed stronger where Sunday Schools operated effectively. To prove his point, Trumbull cited surveys indicating that students entering the university from upper class families who did not send their kids to Sunday School were far less literate than students from less fortunate families who attended Sunday School. The implication is that Sunday School was an important and essential partner in one's education in the 19th century and it remains so today.

Sunday School is not just for children. One of the best strategies for training parents is adult Sunday School classes. If we intend to prepare the next generation of children to follow Christ faithfully and advance the cause of the Kingdom, the children will need parents who are well trained for this awesome responsibility. The effective adult Sunday School Class is a place where parents and grandparents can learn and then go apply the word of God in their lives. Adults of all ages will need a good understanding of the Holy Bible to encourage them in victories and in the difficult times.

Is Sunday School Still Relevant? We believe it should be of the greatest importance in any true Christian's life. Can we adequately grow our religious education in just thirty to forty -five minutes a week? We believe not. Some churches have Wednesday and Sunday Night Bible Studies that adds additional time for instruction. Yet these times of instruction by a qualified teacher need to be accompanied with a time of personal study by students of all ages. And yes, our Sunday School teachers should be qualified. A teacher should be able to instill a love for God's Word that they themselves possess. Paul admonished Timothy concerning the qualifications of a bishop (pastor) in 1 Timothy 3 to include not being a "novice" and also being "apt to teach" (skillful in teaching). These qualities should be a part of anyone who teaches the Word of God. We need to be vigilant in the teaching of God's Word to Christians of all ages in order to build and preserve the truths that we know are real. Our Sunday Schools should be the place we train the generation of today <u>and</u> tomorrow for the work of the church in fulfilling the Great Commission of our Lord and Savior Jesus Christ. After all, "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness: That the man of God may be perfect (*complete*), thoroughly furnished unto all good works." 2 Timothy 3:16-17.

If we sincerely desire to see our churches flourish and be that light to a dark and dying world, we need to ensure that the truth is taught to all those who "do hunger and thirst after righteousness: for they shall be filled." Matthew 5:6

### **Historical Table**

Before 1846, this was part of the Western District Association. The Western District Association was organized in 1822 and is one of the oldest Associations in the state. From this, we go back into North Carolina and West Virginia where they were colonies under England. It was in these colonies that the Baptist patriot, Patrick Henry, defended the Baptist preachers before the colonial officers who were appointed by England, and it was here in these colonies that we find Thomas Jefferson who wrote the Declaration of Independence, making inquiry about the Government of Baptist Churches and Associations that he might get a model after which to assist in forming the Government of the United States. The oldest Baptist Association in the United States is the Philadelphia Association which has done more for Missions than perhaps any other.

### **Rules of Decorum**

- ARTICLE 1. The Association shall be opened and closed with prayer.
- ARTICLE 2. The Moderator and Clerk shall be chosen by members present providing nothing be so construed as to prohibit newly constituted churches petitioning for admission from voting.
- ARTICLE 3. The Moderator shall be considered the judge of order, but any messenger not satisfied with his decision may appeal, provided the appeal is made the same day, but at no subsequent term.
- ARTICLE 4. The Moderator shall be entitled to the same privilege of speaking as other members, so as not to vote, unless his vote be necessary to decide the question. If he arises to speak he shall call another brother to take the chair.
- ARTICLE 5. All questions brought before the Association shall be introduced by motion, and if seconded, shall be opened to discussion, unless withdrawn by the mover or his second. When a subject has been taken up and a reasonable time allowed for discussion, the Moderator shall take the question by yeas and nays and if a call is made it shall be decided by the members rising.
- ARTICLE 6. Any member wishing to speak shall arise and address the Moderator. Only one member shall be allowed to speak at the same time, who shall not be interrupted while speaking, unless he departs from the subject or makes personal reflection.
- ARTICLE 7. No person shall speak more than once on any subject until all who wish to speak have an opportunity, nor more than twice upon any subject without permission.
- ARTICLE 8. Every subject introduced for discussion shall be first decided before another shall be offered, unless it be laid over by motion with the consent of the mover and the Association.
- ARTICLE 9. The Association shall in all cases be governed by a majority vote of the members present, except in the reception of the churches; then a unanimous vote shall be required.
- ARTICLE 10. The names of the members shall be called whenever the Association shall direct, and the absentees marked. Any member wishing to retire shall obtain permission from the Moderator.
- ARTICLE 11. The appellation of "brethren" shall be used by the mem-

bers in addressing each other.

- ARTICLE 12. Any member violating these rules shall be subject to reproval by the Moderator, but only on the day the breach shall have been made.
- ARTICLE 13. Amendments or alterations may be made to these rules when a majority deems it necessary.
- ARTICLE 14. It shall be the duty of the Association to appoint a finance committee to keep up with the moneys during the association, to make their report when called upon and to turn the moneys received over to the Clerk.

### **Church Covenant**

Having been led, as we believe, by the Spirit of God, to receive the Lord Jesus Christ as our Savior, and on the profession of our faith, having been baptized in the name of the Father, and of the Son, and of the Holy Ghost, we do now in the presence of God, angels and this assembly, most solemnly and joyfully enter into covenant with one another, as one body in Christ.

We engage, therefore, by the aid of the Holy Spirit, to walk together in Christian love; to strive for the advancement of this Church, in knowledge, holiness and comfort; to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the Church, the relief of the poor, and the spread of the Gospel through all nations.

We also engage to maintain family and secret devotion; to religiously educate our children; to seek the salvation of our kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements and exemplary in our deportment; to avoid all tattling, backbiting, and excessive anger; to abstain from the sale and use of intoxicating drink as a beverage, and to be zealous in our efforts to advance the kingdom of our Savior.

We further engage to watch over one another in brotherly love; to remember each other in prayer; to aid each other in sickness and distress; to cultivate Christian sympathy in feeling and courtesy in speech; to be slow to take offense, but always ready for reconciliation and mindful of the rules of our Savior, to secure it without delay.

We moreover engage that, when we remove from this place, we will as soon as possible unite with some other church where we can carry out the spirit of this covenant and the principles of God's word.

### **Constitution**

- ARTICLE I. The Association shall be called *Southwestern District Missionary Baptist Association*, known as an advisory council.
- ARTICLE II. It shall be composed of such persons as have been duly elected by such church as may belong to this union to represent them in body.
- ARTICLE III. The messengers representing the different churches shall at the opening of the Association present their letters of correspondence which shall state their appointment as messengers, together with the number of members in fellowship, the number baptized, received by letter, dismissed by letter, excommunicated, restored and dead during the year.
- ARTICLE IV. Every church belonging to this body shall be entitled to three messengers.
- ARTICLE V. Churches of this union failing to represent themselves at one Association will be expected to state reasons for their failure at the next Association, and if any church fails for two consecutive meetings, the Association shall send a committee to inquire into their state.
- ARTICLE VI. New churches may be admitted into this union by signifying their wish by messenger and letter, provided they be deemed orthodox, and are willing to walk in fellowship with us.
- ARTICLE VII. The Association shall have a Moderator and Clerk, who shall be chosen at each annual meeting, as soon as the letters from the different churches are read and their member's names enrolled, provided, also that all newly constituted churches petitioning for union with us shall have full right to vote for Moderator and Clerk, and nothing shall be construed as to prohibit them from voting.
- ARTICLE VIII. This Association shall have no power to adopt rules that shall at any time infringe upon the independence and rights of the churches. It shall however be at liberty to advise churches belonging to it, or it may

separate from churches as are known to walk disorderly.

- ARTICLE IX. The Association shall have a fund for its expenses, and the churches shall be at liberty to send up such contributions as they may think proper.
- ARTICLE X. Any church of this union having a difficulty that she cannot settle may call for help from her sister churches, or may present the case to this body for advice. Such cases must be presented in the letters of correspondence, stating the reason why it had not or could not be decided by the church.
- ARTICLE XI. When churches of this union have members supposed to possess ministerial gifts, they may call from two or more churches for the aid of their ordained ministers and deacons to examine the individuals and, if thought advisable, to ordain such member or members to preach the gospel which shall be reported at the next association and entered upon the Minutes.
- ARTICLE XII. The minutes of this Association will be read, corrected, and signed by the Moderator and Clerk before the session rise. And no Association shall adjourn, unless in extraordinary cases, until it has finished all its business.
- ARTICLE XIII. The Clerk shall read the Rules of Decorum on the first day of each Association meeting.

### Articles of Faith
